
MOTION PURSUANT TO SUPREME COURT RULE 762(a)

STATEMENT OF CHARGES  
PURSUANT TO SUPREME COURT RULE 762(a)

Lea S. Gutierrez, Administrator of the Attorney Registration and Disciplinary Commission, by her attorney, Rory Patrick Quinn, pursuant to Supreme Court Rule 762(a), reports to the Court that on the date Boney M. Patel (hereinafter “Movant”) filed a motion requesting that his name be stricken from the roll of attorneys, a three-count complaint was pending against him before the Commission Hearing Board relating to Movant’s convictions for attempted criminal sexual assault and aggravated battery in the matters entitled *State v. Patel*, docket numbers 21CR0191501, 21CR021800 and 21CR098310 in the Circuit Court of Cook County. Had Movant’s conduct been the subject of a hearing, the Administrator would have introduced the evidence described below, and that evidence would have clearly and convincingly established the misconduct set forth below:

I. FACTUAL BASIS

Movant’s admissions, documents from the Circuit Court of Cook County cases of *People v. Patel*, docket number 21CR0191501; *People v. Patel*, docket number 21CR021800; and *People v. Patel*, docket number 21CR098310, including certified copies of the indictments and the judgments of conviction, and the testimony of various individuals would establish the following facts:

1. On February 5, 2021, a grand jury in the Circuit Court of Cook County issued two indictments against Respondent, docketed as case numbers 21CR0191501 and 21CR021800. In case number 21CR0191501, the indictment alleged that Respondent pushed his way into the apartment of a neighbor, grabbed the neighbor's robe and forced her onto her bed. Respondent and the neighbor then struggled over her phone. The neighbor escaped and used another neighbor's phone to call the police. Respondent fled with the neighbor's phone. The grand jury charged Respondent with home invasion, aggravated kidnapping, residential burglary, robbery, attempt criminal sexual assault, and unlawful restraint. In case number 21CR0218001, the indictment alleged that Respondent, while an inmate of the Cook County Department of Corrections, received medical care from a paramedic employed by the Cook County Sheriff's Office. When the paramedic turned to retrieve a piece of equipment, Respondent grabbed her buttocks without consent. The grand jury charged Respondent with a single count of aggravated battery.

2. On July 23, 2021, a grand jury in the Circuit Court of Cook County issued a third indictment against Respondent, which was docketed as case number 21CR0983101. In that case, Respondent surreptitiously followed a female bar patron into a restroom stall. He grabbed her and tried to keep her in the bathroom stall with him. The bar patron was able to escape Respondent's grasp and alerted bar staff to Respondent's actions. The grand jury charged Respondent with the offenses of attempted criminal sexual assault and unlawful restraint.

3. On July 20, 2023, Respondent pled guilty to felony charges in each of his three criminal cases in the Circuit Court of Cook County. Respondent pled guilty to two counts of attempted criminal sexual assault in violation of Illinois Compiled Statute Chapter 720, Act 5, Section 8-4(11-1.20(a)(1)), and one count of aggravated battery in violation of Illinois Compiled Statute Chapter 720, Act 5, Section 12-3.05(d)(5)(i). Respondent was sentenced to 943 days of

incarceration (time served) at the Cook County Department of Corrections and 30 months of sex offender probation. The sentencing judge ordered Respondent to provide a sample of his DNA for indexing, register as a sex offender for the rest of his life, submit to STD/HIV testing, refrain from violating the criminal statutes of any jurisdiction, refrain from possessing a firearm or other weapon, notify his monitoring agency of any change of address, not leave the State of Illinois without consent of the court, comply with his reporting and treatment requirements, and ordered him to pay fines, fees, and costs.

## II. CONCLUSIONS OF MISCONDUCT

4. By reason of the conduct described above, Movant has engaged in the following misconduct:

- a. committed criminal acts that reflect adversely on his honesty, trustworthiness or fitness as a lawyer in other respects, by conduct including his conviction for the criminal offenses of: attempt to commit criminal sexual assault , in violation of Illinois Compiled Statute Chapter 720, Act 5, Section 8-4(11-1.20(a)(1)); and aggravated battery, in violation of Illinois Compiled Statute Chapter 720, Act 5, Section 12-3.05(d)(5)(i); all in violation of Rule 8.4(b) of the Illinois Rules of Professional Conduct (2010).
