M.R.032380 - In re: Daniel Warren Thomann. Disciplinary Commission.

Motion by respondent Daniel Warren Thomann and request for a hearing on the Administrator's petition for reciprocal discipline pursuant to Supreme Court Rule 763. Denied.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763(a)(1). Allowed. Respondent Daniel Warren Thomann, who has been disciplined in the United States Court of Appeals for the Seventh Circuit, is suspended from the practice of law for one (1) year in the State of Illinois.

Suspension is effective February 13, 2025.

Respondent Daniel Warren Thomann shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

Respondent Alison Kleinhenn Devis, who has been disciplined in the State of Indiana, is suspended from the practice of law in the State of Illinois for ninety (90) days and until further order of the Court.
